



Crude prices are drifting lower this morning after reaching the high for the month at \$74.17/bbl earlier in the week. The benchmark is still on track for a third weekly gain. Expected reductions in global supply from tighter restrictions against Iran and Venezuela are set against the return of OPEC+ supply in April and heightened Middle East tensions.


