Lithium Hydroxide Commentary

It's been a quiet end to the week, with many returning from conferences and events. The curve has had an offered tone today, with strong offer interest out of Asia. Most the trading activity has come from the longer end however we did see Q325 and Q425 trade down at 9.70 and 10.15 respectively, from 9.85 and 10.25 the previous day. Further out Q126 traded down from 10.70 to 10.65 where it was offered on and Q226 traded at 11.15 in 25tpm all day where it was also offered. Q326 trading initially at 11.70, then down to 11.65, with CME marking val at 11.85. FM index remined unchanged.

Cobalt Commentary

Like yesterday, we saw good spread interest, buying the shorter end against selling tenors out to Q228. The curve has continued to move higher off the back of this week's strong buying interest and another index rise. Mar25 v Apr25 traded at 0.4c (11.00 v 11.40) in 47t all day. The other spread to trade was Q225 v Q426 at 1.3c. At the time, both these spreads had further interest to borrow.
