The London afternoon initially opened weaker reaching session lows of \$101.75. However, into close we pushed higher before closing at \$102.20. Outrights saw minimal trades of note but Q3 traded in a total of 20kt across a few clips.


Spreads continued some of the strength with May/Jun trading \$1 in 30kt followed by Apr/May \$1.20 in decent size across multiple clips. Spreads further out showed a slight pull back on strength in the Singapore day, Q2/1H traded \$7.70 in 20/10kt and Q2/Q4 traded \$4.70 in 20kt total. Elsewhere, Mar/Q3 traded \$4.35 as flat price pushed up.
