President Donald Trump ratcheted up pressure on Iran to rein in the Houthis, raising the possibility of retaliatory strikes against the Islamic Republic if the militant group in Yemen doesn't stop its attacks. Canadian oil brokerage One Exchange Corp. hired former Macquarie Group Ltd. crude trader Kaye McKee as it expands into the US market. Chevron Corp. bought nearly 5% of Hess Corp. in an unusual move designed to show confidence that it will win the arbitration battle with Exxon Mobil Corp. that has delayed its planned takeover of Hess for more than a year. Nigeria's Dangote oil refinery is currently operating at about 80% of capacity, IIR Energy said in an emailed statement Monday.






