President Donald Trump appeared to invent a new weapon of economic statecraft by threatening "secondary tariffs" on countries that buy oil from Venezuela The UK could supply half of its oil and gas consumption from domestic sources by 2050 if the right policies were in place, a lobby group said. Colonial Pipeline Co. defended a proposal for changes on its fuel network after objections from Exxon Mobil Corp., Chevron Corp. and Trafigura. Shell Plc will update its strategy on Tuesday, just a month after struggling rival BP Plc unveiled a fundamental "reset." US and Russian officials met in Saudi Arabia for about 12 hours a day after American and Ukrainian teams held talks, as President Donald Trump pushes for progress in achieving a ceasefire in the war.






