

#### **Market Commentary / Recent Trades**

The Singapore morning session opened at \$101.30 and saw price drop to \$100.65 before gradually drifting higher for the duration of the session to highs of \$101.70. In the afternoon we saw a large sell off shortly after the open, with price tanking to new daily lows of \$99.50, the session closed at \$99.90.

In the morning, we saw interest on quarterly spreads with Q2/Q3 trading at \$2.40 in a total of 50ktm, we also saw some Q3 outright interest in 30ktm+. Apr/May traded at \$1.00 in 337.1kt and we also saw Apr/Q3 print \$3.45 in 375x125ktm. In the afternoon Q2/Q3 had perpetuated interest at \$2.40 in a further 35ktm as well as another 30kt at \$2.45, we also saw another 20ktm of Q3 outrights print. Mar/Jun traded at \$3.05 in 100kt early in the session, however as flat price dropped, we saw the market widen and another 100kt traded at \$3.25.

We also saw Apr/Jun trade at \$1.80 in 50kt and \$1.85 in 31kt as well as Mar/May trading at \$1.65 in 50kt. Jun outrights had some interest with 2x 60kt clips trading.



#### 市场评论 / 近期交易

新加坡早盘开盘于101.30美元,价格一度下探至100.65美元,但在随后交易时段内逐步回升,最高触及101.70美元。午盘开始后市场出现大规模抛售,价格大幅下跌至99.50美元的日内新低,最终收于99.90美元。

早盘季度价差交易较为活跃,Q2/Q3单月成交量5万吨成交于2.40美元,Q3也有直接兴趣,总成交量超3万吨。4月/5月成交价为1.00美元,成交量33.71万吨,4月/Q3依次成交于3.45美元(单月12.5万吨)。

午后Q2/Q3继续受到关注,另有单月3.5万吨成交于2.40美元,同时再有3万吨成交于2.45美元,Q3直接交易也有额外2万吨成交。3月/6月早盘成交总量达10万吨,价格为3.05美元,但随着期货价格下跌,价差扩大至3.25美元后又成交10万吨。此外,4月/6月分别有5万吨成交于1.80美元,3.1万吨成交于1.85美元,3月/5月则有5万吨成交于1.65美元。6月直接交易兴趣良好,有两笔6万吨成交。
