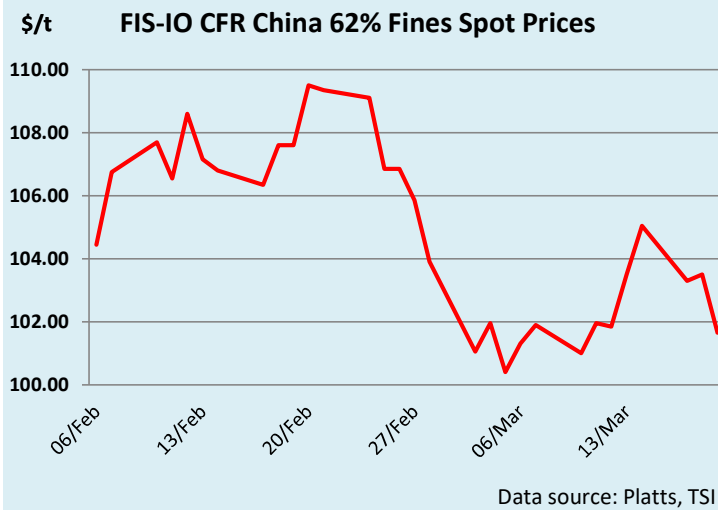

## Market Commentary / Recent Trades

The Singapore iron ore futures market opened weaker, with Apr reaching a morning low of \$100.20. Despite this, some buying interest returned on Jun contract, with 200kt traded in 50kt clips. Spreads remained stable, with Jun/Jul trading at \$0.80 in 50kt, while Mar/Apr saw trades at \$1.30 in similar volumes.

In the afternoon, sentiment weakened further as the Apr dropped to \$99.75. This downward move was accompanied by spread tightening, with Q2/Q3 initially trading at \$2.50 in small lots before slipping to \$2.45 on 15kt volume. Apr/Jun traded actively at \$2 in 200kt, while Q3/Q4 saw greater volume at \$2 for 50kt, later narrowing to \$1.95 in 5kt trades. The Q2/Q4 spread also began trading at \$4.40.

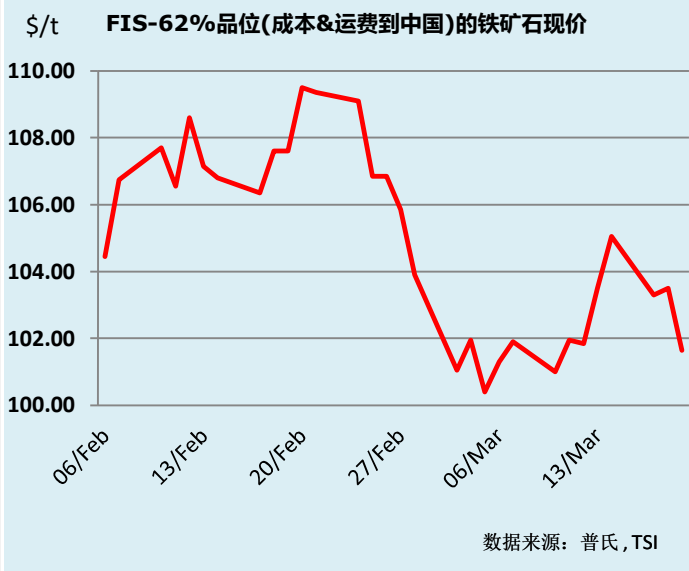

## 市场评论 / 近期交易

新加坡市场早盘期货价格走弱，4月合约跌至100.20美元的低点。随后6月合约出现买盘兴趣，多次交易5万吨，总计20万吨。价差相对稳定，6月/7月在0.80美元成交5万吨，3月/4月在1.30美元成交5万吨。

午盘市场进一步走弱，4月价格跌至99.75美元的低点，随后价差收窄。Q2/Q3在2.50美元有少量交易，随后在2.45美元总计交易1.5万吨。此外4月/6月在2.00美元成交20万吨。Q3/Q4同样在2.00美元有不错的交易量，总计5万吨，随后在1.95美元成交5,000吨。Q2/Q4交易于4.40美元。
