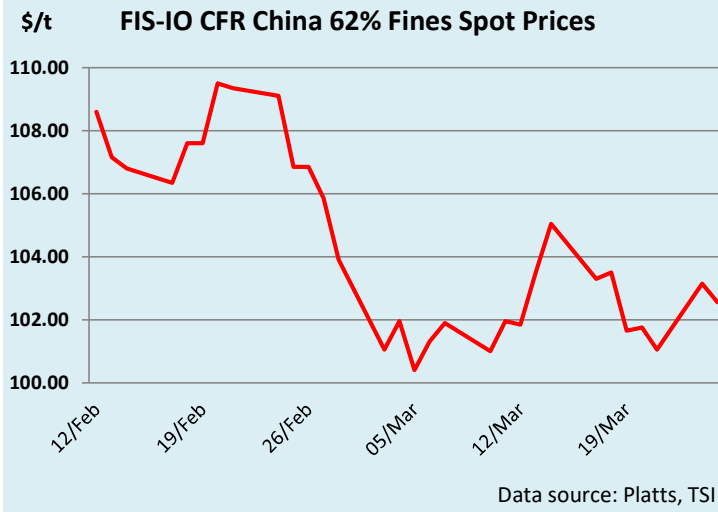

## Market Commentary / Recent Trades

The Singapore market opened the morning session on a steady note, with flat prices remaining stagnant before softening to an intraday low of \$101.35. However, a partial recovery followed, bringing the market back up to close at \$101.70. Prompt-month spreads narrowed, with April/May trading at \$1.05 on a volume of 200kt.

The afternoon session saw further weakness, with prices hitting a fresh daily low of \$101.15. Selling interest was particularly evident in the Q3/Q4 structure, which traded at \$1.90 on over 30kt. Additionally, the Jun/Q4 spread saw activity at \$3.50, with volumes of 90/30kt. Post-close, prompt spreads continued to tighten, with April/May narrowing further to \$0.95 on over 300kt traded.

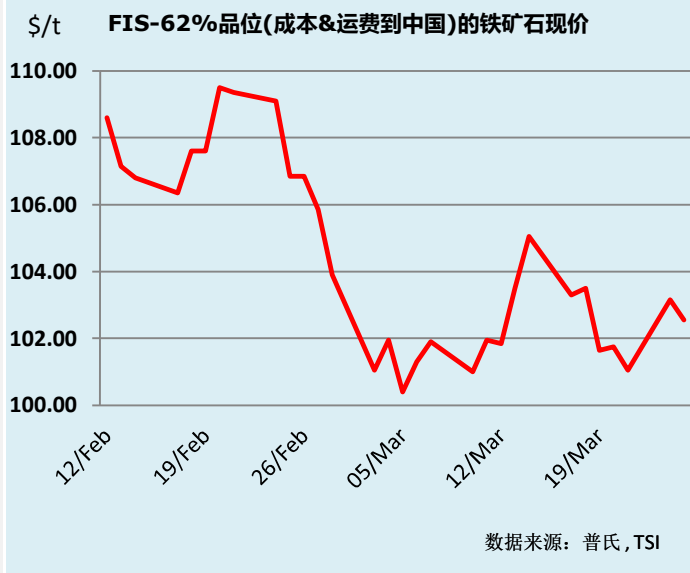

## 市场评论 / 近期交易

新加坡市场早盘价格相对稳定，随后下跌至101.35美元的低点，经过小幅反弹，最终收于101.70美元。即期合约价差收窄，4/5月价差交易于1.05美元，总计20万吨。

午盘价格进一步走低，跌至101.15美元的日内新低，同时Q3/Q4卖盘较为活跃，在1.90美元交易超3万吨。6月/Q4在3.50美元交易3至9万吨。盘后交易即期合约价差继续收窄，4/5月在0.95美元交易超30万吨。
