


Oil and Energy Market News

Crude markets have steadied after yesterday's decline of 2% amid a potential OPEC+ output increase, US tariff uncertainty and ongoing US-Iran nuclear talks. This morning, we have seen Brent Crude rise 0.90% since open. A WSJ report announced Trump was considering cutting tariffs on China and moving to a tiered tariff system, Trump administration officials have since countered the article, saying any tariff cut will not be unilateral. A number of OPEC+ members want to approve another accelerated oil output increase for June at their upcoming meeting, scheduled for the 5th May, Reuters said.


