<u>Lithium Hydroxide</u> Commentary

Today saw a total of 233tpm trade, primarily across the back end of 2025 and into 2026, following suit to much of this week. Overall, the curve has continued its move lower, settling roughly 1.25% lower across the curve. This morning Q226 printed in good size at 10.75, 1.5% lower on the day. It closed offered via spread Q325 v Q226 at 1.35c. Other main tenors to trade include Jun25 against Q126 (9.10 and 10.30), all day, approximately 60tpm went through. The other main tenor to trade was Q126, with all prints at 10.30, 1% lower on the day. Q126 closed 10.30/10.40 in 5tpm/10tpm.
