#### IN THE NEWS [Bloomberg]

A group of 50 Republican and Democratic senators introduced a sanctions package to hit Russia and countries buying its oil if President Vladimir Putin refuses to engage in good-faith ceasefire talks over Ukraine. Ukraine's top diplomat said officials are pressing ahead with the US toward an "acceptable" economic accord hours after President Donald Trump accused Kyiv of trying to renegotiate the deal. Colombia's state-owned Ecopetrol SA is considering buying Carlyle Group's oil driller as it looks to boost reserves and output. China's energy giants are pivoting to natural gas to raise production, as demand for oil slows and global trade tensions heighten risks. US West Coast refiners imported a record amount of Canadian oil as the threat of tariffs and high prices for other grades spurred buying. OPEC reduced oil production last month, with curbs in Nigeria and Iraq, before the group proceeds with long-delayed plans to revive halted output. Russia's oil exports fell sharply, with a three-day halt to loading activities at a key Pacific export terminal keeping weekly flows in check.


