Market Commentary / Recent Trades

Iron ore futures in the Singapore market traded in a relatively subdued manner today, marking a quieter session following a volatile week. Prices during the morning session remained largely rangebound between \$95.85 and \$96.85, with moderate activity in May contracts, where trade volumes reached up to 50,000 tonnes per clip. In the afternoon, the market saw a modest upward move, with the flat price climbing to an intraday high of \$97.20, buoyed by improving global growth sentiment.

Inter-month spreads also remained active. April/May spreads saw consistent trading throughout the morning, with volumes between 25,000 and 50,000 tonnes at varying levels, influenced by fluctuations in the underlying flat price. Further down the curve, Q3/Q4 spreads traded steadily at \$1.85 with over 50,000 tonnes changing hands during the morning and similar volumes observed in the afternoon. The Q3/Q3 spread initially printed at \$6.20 for 25,000 tonnes before easing slightly to \$6.15 in smaller transactions. The May/1H spread recorded firm demand, trading a total of 90,000 tonnes at \$6.30. Additionally, the Apr/Jun spread attracted significant interest, transacting 150,000 tonnes at the \$3.00 mark.
