



July 25 Brent Crude is up 2.75% on the day from its \$61.06/bbl open. Crude has extended earlier gains, due to signs of easing trade tensions supported by US announcements regarding a trade deal with the UK. Looming US-China trade talks on Saturday are also supportive. US President Donald Trump alongside UK Prime Minister Sir Keir Starmer have touted a new trade agreement characterised by Trump as the "first in a series of agreements on trade".

With June Brent Crude up 2.75%, and cracks flat, we have seen a good push on flat price today across both hubs. The June Sing 0.5% contract is trading \$8.00 higher than its settlement figure. Spreads stay bid throughout the day with the Sing 0.5% June / July trading at highs of \$8, up \$1 from settlement. This trend carried through to the high sulphur product too, with the June / July Sing 380 contract trading at \$11.25, up from its \$10 settlement.
