With GFEX off 3%, the curve has moved roughly 2% lower over the day. The main tenors trading include Q325, Q425, and Cal26. Q325 traded 8.35, then 8.40 in various clips over the day, 1% lower than yesterday's levels. Cal26 printed 9.95 initially, with its last trading level down at 9.90.
