Tumbling oil prices dragged the value of Russia's crude exports to the lowest in more than two years, forcing the Kremlin to consider tightening its key budget-building mechanism while the war in Ukraine continues to drain state coffers. After buckling under pressure from Beijing and Washington, the clandestine supply chain that carries Iranian crude to China is finding new workarounds. Russia kept its crude oil production below the nation's OPEC+ quota in April, according to people familiar with the data. Harbour Energy Plc, the UK's biggest independent oil and gas producer, began a review of its North Sea operations that it expects to result in job cuts. Exxon Mobil Corp. plans to invest \$1.5 billion in a deepwater oil field in Nigeria as Africa's top producer looks to boost output, according to the nation's regulator.
