Market Commentary / Recent Trades

The Singapore day opened higher—despite the Singapore public holiday-on expectations of improved US/China trade relations. However, little concrete news was provided early on, resulting in iron ore trading down to a low of \$97.60. The afternoon saw the release of the following news: China to lower tariffs on US goods to 10% from 125% for 90 days. US to cut tariffs on Chinese goods to 30% from 145% for 90 days.

This culminated in strong bid interest in both flat price and spreads. The front month traded up to a high of \$100.10, with clips of June and July trading in decent size across multiple trades. Spreads widened, with Q4/Q2 trading at \$3.10, Q3/Q1 at \$3.85 in 15kt, and Q4/Q1 at \$1.80 in 20kt. June/Q2 was also seen trading at \$7.30. Further out, June/Cal26 traded from \$8.00 out to \$8.10.



市场评论 / 近期交易 尽管适逢新加坡公共假期,由于市场预期中美贸易关系将改善,新加 坡市场开盘价格上涨。然而早盘并无实质性消息公布,铁矿石价格回 落至97.60美元的日内低点。午盘市场传出消息,中国将在未来90天 内将对美商品关税从125%下调至10%,美国则将在同一时期将对中 国商品的关税从145%下调至30%。

此消息推动期货及价差买盘强劲。即期合约涨至100.10美元,6月及 7月合约交易量可观。价差扩大,Q4/Q2交易于3.10美元,Q3/Q1在 3.85美元交易1.5万吨,Q4/Q1在1.80美元交易2万吨。6月/Q2交 易于7.30美元。远期合约方面,6月/Cal26从8.00美元扩大至8.10 美元。 99.00
