Market Commentary / Recent Trades

The Singapore morning saw flat price reach a session high early on at \$101.45, before trading slightly lower for the remainder of the session to a daily low of \$100.85. Spreads saw May/Q3 trade at \$2.30 in 30/10kt, Jun/Jul at \$1.15 in 50kt, and Q3/Q4 narrowed to \$2.35 in smaller clips.

The afternoon session saw renewed bid support, with flat price reaching a daily high of \$101.65. Spreads followed suit, with Q3/Q4 widening to \$2.40 in 15kt, and further out, Jun/Cal26 traded at \$8.80. The late afternoon brought offer pressure, with Jul/Aug trading at \$1.05, Jun/Oct at \$3.95, and Jun/Jul at \$1.15.
