



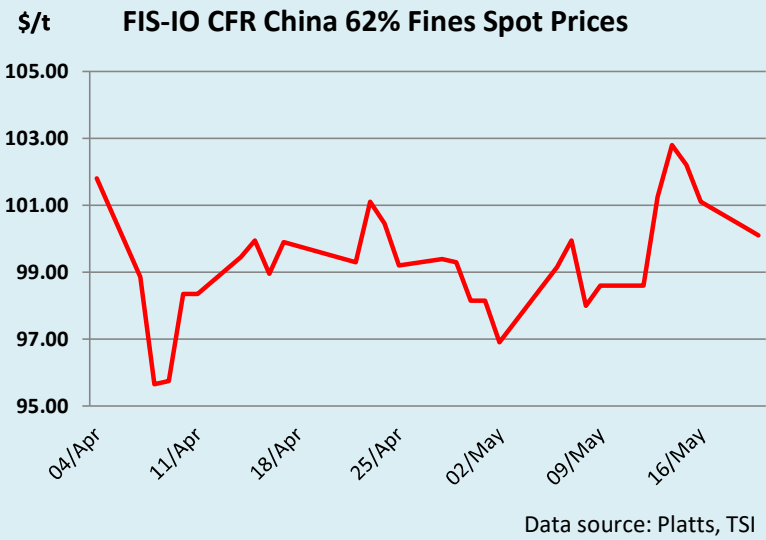

Market Commentary / Recent Trades

The Singapore morning session opened at \$99.25 and once again saw price contained in a tight range comprising lows of \$99.25 and highs of \$100.05. In the afternoon, price rallied to a daily high of \$100.20 before selling off to close at \$99.55. In the morning, we saw Q3/Q4 trade at \$2.40 in 50ktm, as well as Q3/Q1 trading at \$4.25 in 10ktm. We also saw May/Jul trading at \$1.35 in 60kt, and Jul/Q4 trading at \$3.40 in 196x65ktm. In the afternoon, Jun/Aug traded at \$1.95 in 150kt, Jul/Aug traded at \$0.95 in 180kt, and Jul/Sep traded at \$1.85 in 170kt.

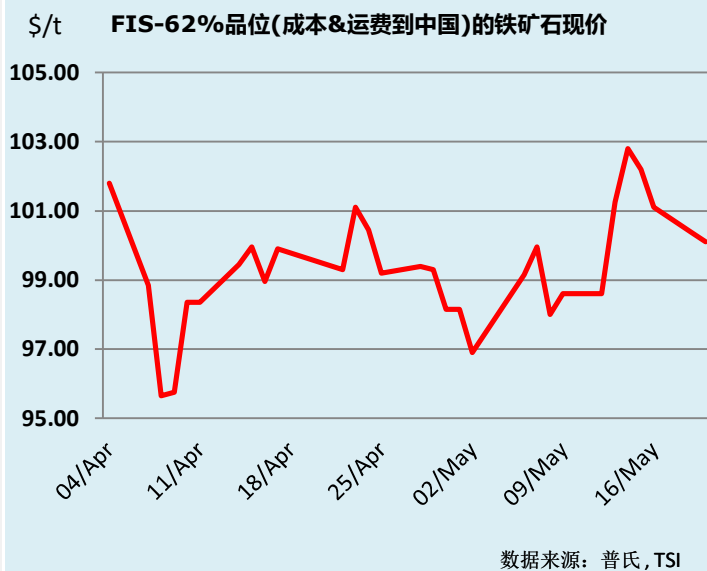
