


Oil and Energy Market News

Crude prices are slightly lower today but are largely retaining Friday's 2% gains, supported by improved risk sentiment as concerns over tariffs subside ahead of upcoming US-China trade talks. Oil remains near the upper end of its recent trading range—between approximately \$62 and \$66.80 per barrel—where it has hovered since mid-May amid subdued volatility. The US and China are scheduled to hold trade discussions in London on Monday, with markets closely watching for signs of progress amid worries that rising protectionism could dampen global energy demand.

Fuel Oil Market News

This morning, we have seen LSFO cracks weaken, the July Sing 0.5% crack is currently down \$0.20/bbl from settlement, and the July Rott 0.5% crack is down \$0.11/bbl. The Sing 380 crack is up on the day, trading \$0.23/mt higher than its settlement figure. With a steady Brent we have seen little action on flat price so far. The July HSFO E/W contract strengthens this morning, up \$0.75/mt on the day. We have seen some positive movements on Sing 380 spreads this morning, with the Jul/Aug contract trading \$0.25 higher than settlement.


