


Crude prices are trading higher today as markets focus on upcoming US-China trade negotiations. Brent (August 2025) is up 0.50%. US and Chinese trade officials are scheduled to meet in London on Monday in an effort to advance trade discussions. China's crude oil imports declined in May to 46.6 million metric tons (10.97 million barrels per day), the lowest level in four months, according to customs data. Imports of Iranian crude by China dropped 36% month-over-month in May to below 1 million bpd—the lowest since January, per Kpler. OPEC+ production increased in May, though by less than anticipated, according to a Reuters survey. Bank of America notes that the rise in OPEC+ output is part of Saudi Arabia's strategy to boost market share, enforce discipline among members, and respond to pressure from the Trump administration.

We have also seen a push on Sing 380 spreads, with the July / Aug contract trading \$0.50/mt above settlement.


