## 16 June 2025

The session opened at \$94.33, which was also the high of the day, before steadily dropping to a low of \$93.40 in the afternoon. The June/June spread widened from \$1.10 at the start of the session to \$1.25 by the end. Little activity was seen throughout the session apart from outright months trading in small clips. Notable trades include Dec/Jan trading at \$0.40 in 50kt and August trading at \$93.15 in 111kt.
