The London afternoon session opened at \$92.90, reached a high of \$93.35, and then decreased to a low of \$92.55, where it closed soon after at \$92.65. Spreads saw minimal activity throughout the session, with notable trades including July/August trading at \$0.40 in 50kt.

Outrights saw most of the activity, with July trading in multiple clips of 5 to 10kt and August in clips of 10 to 20kt. Some liquidity was also seen further down the curve, with Cal 26 trading in multiple clips totaling 12kt.

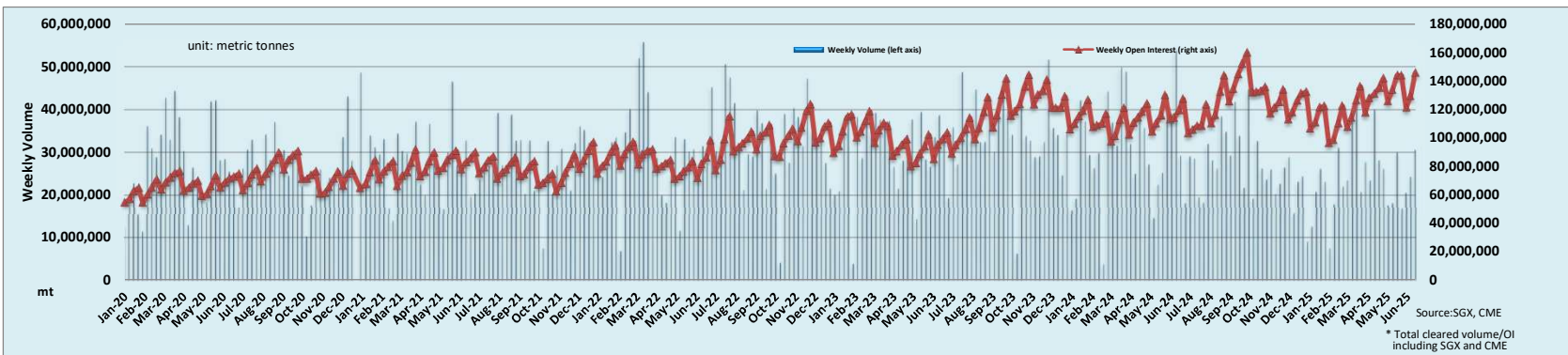
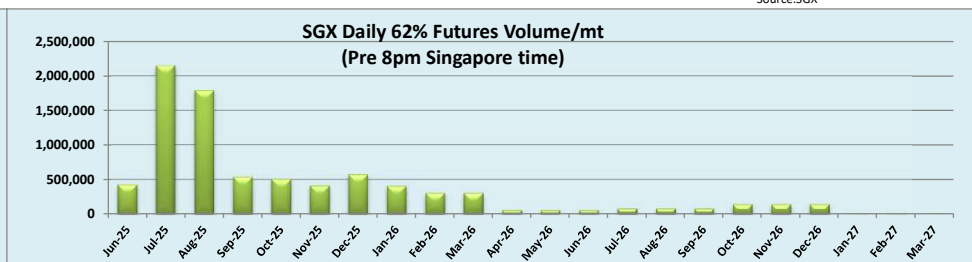
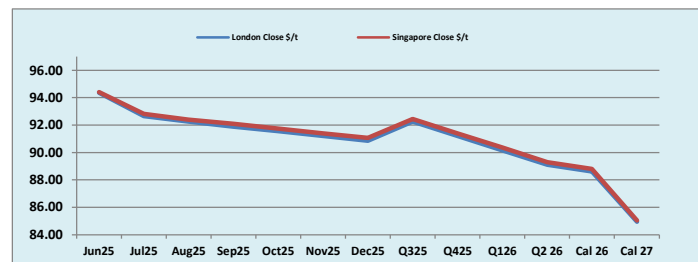
