


The London afternoon session opened at \$92.55, which was also the low of the session. Flat price then climbed to a high of \$93.30 soon after the open, before steadily dropping to close at \$92.80.

Spreads saw activity further down the curve, with Q4-25/Q1-26 trading in multiple clips totaling 220kt, and Q4/Q4 trading in 10kt clips. Outrights were also active, with noteworthy trades including August trading in 100kt and H2-26 trading in smalls.
