The London afternoon session opened at \$92.95, reaching a low of \$92.90. It then climbed to a high of \$93.40 and closed at \$93.15. Little activity was seen in both spreads and outrights, with the majority of trades being outrights in July and August in smalls. Bid support can be seen at the front of the curve, with July/Sep trading at \$0.95 in 50kt. Further out the curve, spreads continued to widen on the day, with Q3/Q3 trading at \$4.65 in 10kt.
