
The London afternoon session opened at \$93.85, which was also the low of the session, before rising to a high of \$94.25 at the close.

Outrights and spreads saw activity throughout the curve. In prompt month outrights, multiple small clips of June and July traded, while August was seen trading in 75kt. In spreads, July/August traded at \$0.45 in 100kt at the start of the session before spreads widened, alongside additional small clips. Further down the curve, Q3 traded in multiple clips of 15–20kt, and August/Q4 traded at \$1.25 in 60/20kt.
