
The London afternoon session opened at \$94.20, which was also the high of the session. Flat price then dropped to a low of \$93.95 before rising again to a close of \$94.05.


Outrights traded in smalls throughout the session, with July and August seeing the bulk of activity, ranging in clips of 5–20kt.

Most of the volume traded during the session was seen in the July/August spread, trading at \$0.25 in numerous 50kt clips, totalling 530kt. Further down the curve, a Q3/Q1-26 was seen trading at \$2.05 in 20kt.
