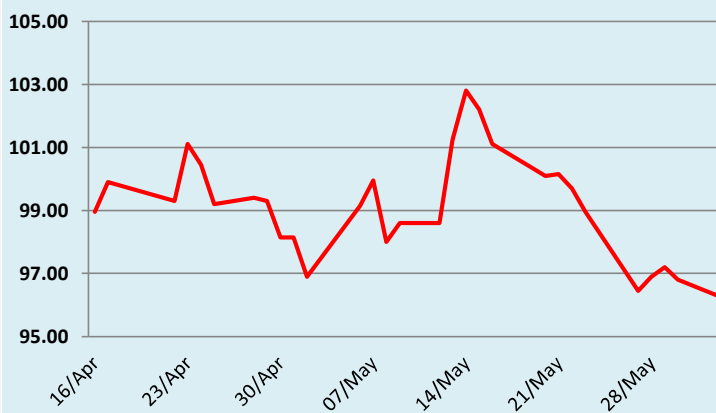

Market Commentary / Recent Trades

Trade was subdued in Singapore today, with the DCE closed for China's public holiday. Futures drifted lower in light volumes. June last traded at \$95.90, while Q4 edged down, changing hands between \$92.45 and \$92.55. Cal26 saw stronger interest, with over 100kt trading at \$89.50 before easing to \$89.35.

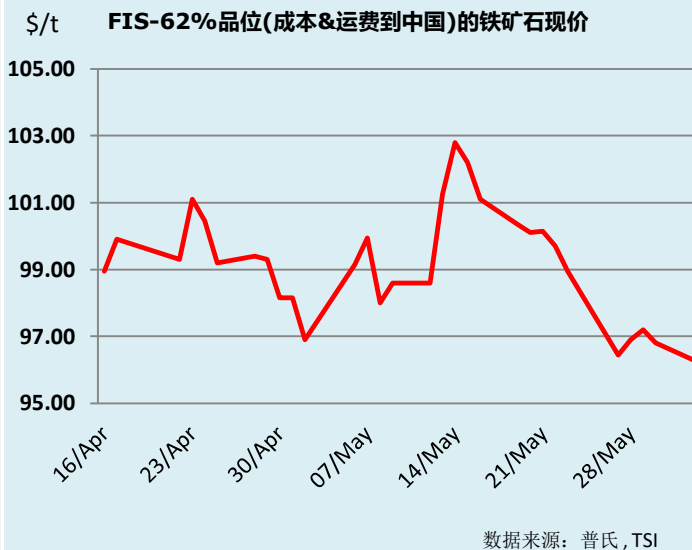
