Lithium Hydroxide Commentary

With GFEX up 2.5%, we have seen the curve follow suit. Aug25 traded up at 8.55. Q126 printed 9.45 and 9.43 in 10tpm each. Into the afternoon we saw a flurry of activity with Q425 vs Q226 trading 0.6 with Q4 at 9.12 and Q2 at 9.72. Alongside these two clips of 10tpm per spread, Q226 traded as an outright in 15tpm total at the same level.
