


London Iron Ore Market Report



07 July 2025

The London afternoon session opened at \$95.25, before dipping to a low of \$94.90. It then climbed to a high of \$95.70, ultimately settling at \$95.55. Outrights dominated the activity during the session. Prompt months traded in small clips, while further down the curve Q4-25 traded in multiple clips ranging from 5–25kt, Q1-26 in two 5kt clips, and Q2-26 in a single 9kt trade. Spreads saw limited action, with the exception of July/Sep trading at \$0.10 in two sizeable clips of 100kt each, and Q4/Cal 26 trading at \$3.05 in 10kt and 2.5kt clips.
