## 09 July 2025

The London afternoon session opened at \$95.75, marking the low of the day, before climbing to a high of \$96.75 and closing at \$96.65. The session saw activity primarily in prompt month spreads. Aug/Sep traded in multiple clips at -\$0.10, totalling 620kt, while Aug/Oct also printed at -\$0.10 in 400kt. Sep/Dec saw some flow as well, trading at \$0.50 in two clips of 50kt each. Further down the curve, Q4/Q1 traded at \$1.00 in a 25kt clip, reflecting some light liquidity beyond the prompt.
