The London afternoon session opened at \$99.20, with flat price rising to a high of \$99.80 before easing to a low of \$99.15 and settling at a \$99.40 close. Activity remained muted, with the bulk of trading focused on prompt month out rights in small clips. In spreads, Aug/Sep continued to widen in contango, moving from -\$0.05 to -\$0.20 on screen, and trading at -\$0.15 in 10kt. Sep/Oct also saw some flow, trading at \$0.10 in 45kt.

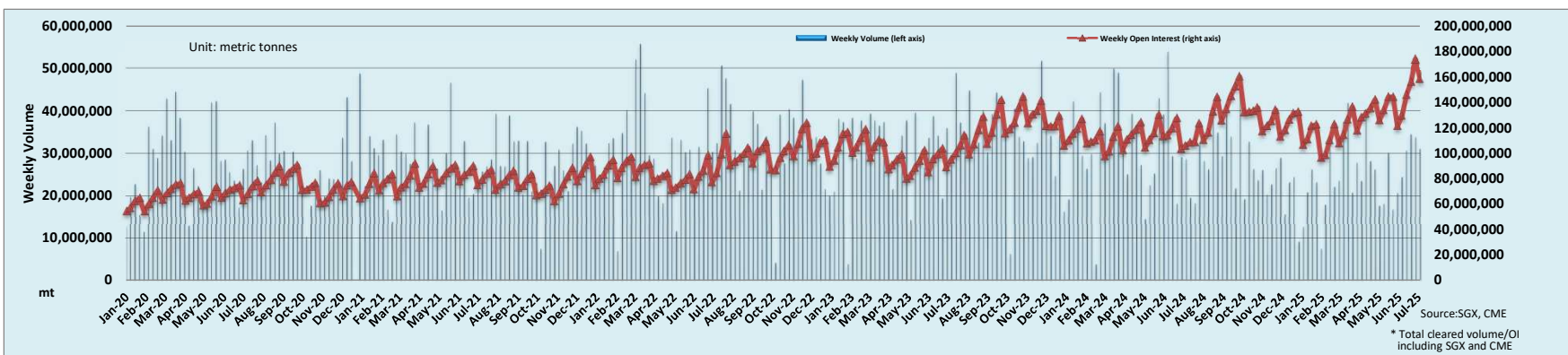
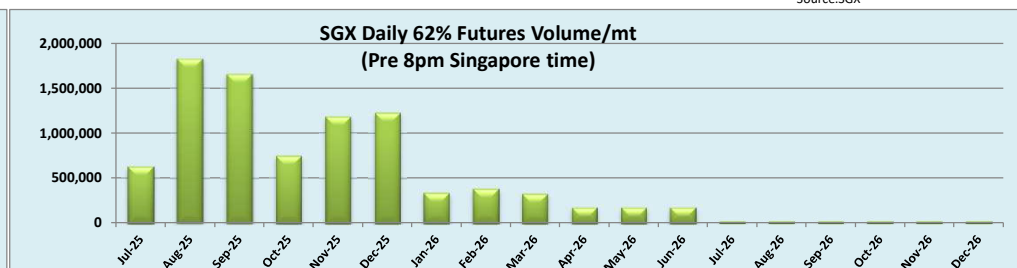
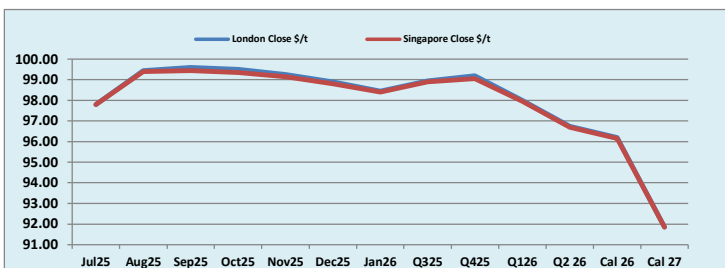
