The London afternoon saw a reversal of the fall in flat price, as we reached session highs of \$102.50, just 10 cents short of the high of the day.

Spreads began the session seeing selling interest, with Aug/Q4 trading at \$0.60 in good size across multiple clips. The push in flat price toward the high near the end of the session saw spreads widen out.
