



The London afternoon session opened at \$100.45, which was also the low of the session. Flat price then climbed to a high of \$101.60 and then closed at \$101.30. Activity was seen across spreads and outrights and spreads. Outrights saw trading throughout the curve, in prompt months, Dec was seen trading in multiple clips of 50kt; further down the curve, Q4 traded in clips of 10kt, and Cal 26 traded in two clips of 5kt. Spreads saw the majority of volume in Aug/Dec and Sep/Dec spreads, being told there was strong selling interest. Both spreads were seen tightening by 5 cents in the session: Aug/Dec started the session trading at \$0.75 in 10kt, whilst further on in the session it traded at \$0.70 in 10+25+110kt clips totalling 145kt. Similarly, Sep/Dec started the session trading at \$1.00 in two clips of 100 and 65kt; it then tightened to \$0.95 in a 65kt clip. Further down the curve, Q4/Q1 traded at \$1.50 in two clips of 5kt, earlier in the day it was trading at \$1.65. Moreover, Q2/Q4 traded at \$3.25 in 10kt. Aug/Sep also traded at -\$0.20 in clips of 10 and 20kt; it started the day at -\$0.20, went to -\$0.15, then came back into -\$0.20 in this session.
