## **London Iron Ore Market Report**





The London afternoon session opened at \$102.65, which was also the low of the session. Flat price then rose to a high of \$103.50, and the session then closed at \$103.45. Little activity was seen in this session except for the Aug/Sep and Aug/Dec spreads trading in size; most trades were seen in prompt month outrights trading in smalls. Aug/Sep was seen trading in multiple clips at -\$0.30, going further into contango from earlier in the day where it was trading at -\$0.20 and -\$0.25. Clip sizes included 100kt, 93kt, 25kt, 35kt, and 167kt, totalling 420kt. Aug/Dec traded at \$0.50 in 250kt, viewed as an eager sell when we have it valued at \$0.60. Sep/Q4 also traded at \$0.50 in 30/10kt; we have it valued at this level, and it has remained unchanged during the day.
