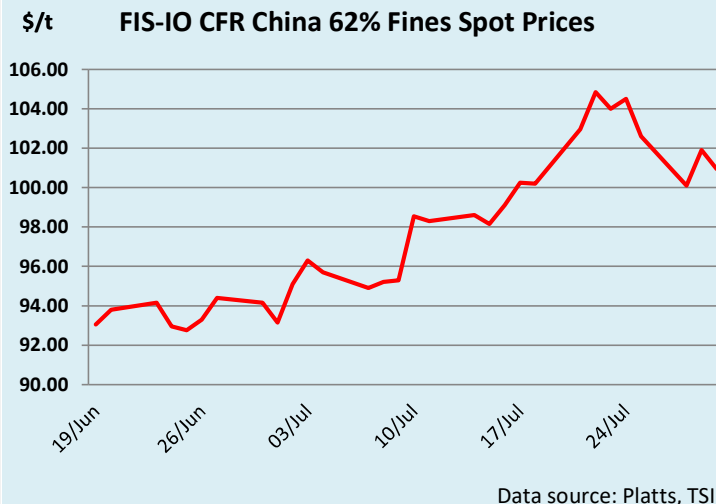

Market Commentary / Recent Trades

The Singapore morning session opened at \$103.35, which was also the high of the session; price then dropped to a low of \$102.30 and closed at \$102.50. Outrights saw little activity during the session, with most of the activity coming in prompt months trading in smalls, except for some Q4 trading in clips of 10kt.

Spreads saw a bit of activity, with Aug/Sep trading at -\$0.30 in smalls and a 200kt clip. Further down the curve, a Q1/Q3 traded at \$3.20 in 10kt.

China has stated it will maintain its macro policy support for the rest of 2025 as the country seeks to navigate economic risks. A party member stated, "Macro policies must continue to exert strength and be stepped up when appropriate." Iron ore prices rebounded yesterday; CISA stated that crude steel output controls will continue through 2025. The China-U.S. economic and trade talks held in Stockholm, Sweden resulted in a consensus to extend the suspended reciprocal tariffs.

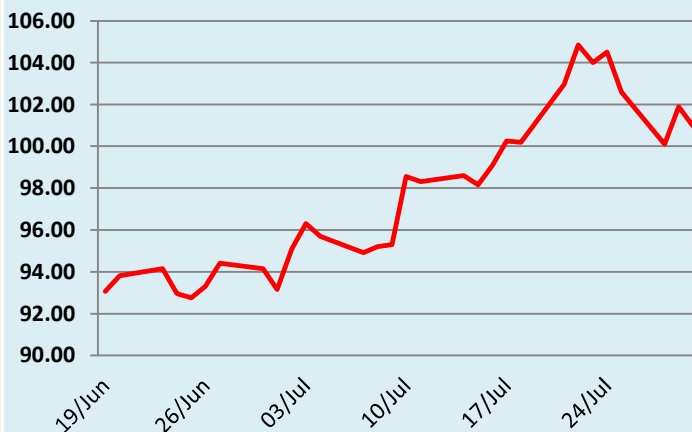
市场评论 / 近期交易

今早新加坡开盘于103.35美元的高点，随后价格下跌至102.30美元的低点，并最终收于102.50美元。盘中单月合约整体交易清淡，近期合约以小额交易为主，Q4多次交易1万吨。

价差方面有一些交易量，8月/9月在负0.30美元除交易一笔20万吨外，其余主要为小额交易。远期合约方面，Q1/Q3在3.20美元交易1万吨。

中国方面表示将在2025年下半年继续维持宏观政策，以应对经济风险。一位官员称：“宏观政策必须继续发力，并在适当时加大力度。”昨日铁矿石价格反弹，中国钢铁工业协会（CISA）指出2025年全年将继续执行粗钢产量控制。此外在瑞典斯德哥尔摩举行的中美经贸会谈达成共识，同意延长暂停征收对等关税的安排。
