The London afternoon session opened at \$102.45, which was also the high of the session. Flat price then dropped to a low of \$101.40 and closed at \$101.50. Little activity was seen during the session, with outrights trading in smalls, including prompt months and Q4 trading in 5kt and 10kt clips. Some spreads saw activity, with Aug/Sep and Sep/Oct staying in contango, trading at -\$0.55 in 35kt and -\$0.30 widening from -\$0.25 in 50+80kt. In addition, Aug/Nov traded at -\$0.90 in 35kt.
