The London afternoon session opened at \$102.15, which was also the high of the session. Flat price then dropped to a low of \$101.40 and rose to close at \$101.80. Little activity was seen in this session, with the bulk of trades coming in Sep, trading in smalls with the largest clip being 40kt. Some spreads were seen trading, with Sep/Dec trading at -\$0.35 in two clips of 50kt and 25kt. Sep/Oct also traded at -\$0.25 in 24kt; earlier in the day, it was trading at -\$0.30.
