


## **London Iron Ore Market Report**



## 08 August 2025

The London afternoon session opened at \$102.10. Flat price then fell to a low of \$101.85 before rising to a high of \$103.00 and closing at \$102.85. Little activity was seen in this session, with most trades coming in prompt months trading in smalls in a range of 5–20kt clips, except for Sep trading in three clips of 50kt. Spreads widened throughout the day, with Aug/Sep moving further into contango from the start of the day, marked at -\$0.65 compared to -\$0.45, and the following prompt month spreads all widening by \$0.05. This transferred to quarterly spreads, with Q4/Q1 trading at \$0.95 in the previous session from \$0.85, whilst Q1/Q2 and Q2/Q3 widened to \$1.60 from \$1.55 at the start of the day.
