The London afternoon session opened at \$100.85, which was also the low of the session. Flat price then rose by \$2 to a high of \$102.85 and closed at \$102.80. Looking at outrights, little activity was seen in the session with prompt months trading in smalls; however, Cal26 traded in clips of 1kt and 3kt. Trading was mainly seen in the Aug/Oct spread. With flat price rising, this contributed to the spread tightening and going back into contango, trading at -\$1.00 at the end of the session compared to being valued at -\$0.10 at the start of the session. Aug/Oct was seen trading in clips ranging from 25–100kt, totaling 458kt. Levels traded included -\$0.10, -\$0.20 (bulk of trading), -\$0.35, -\$0.55, and -\$1.00. Aug/Sep also saw liquidity and followed suit in going into contango. At the start of the day, value was at \$0.65, and in the session, it was seen trading at -\$0.75 in 15kt and -\$0.30 in 15kt. In contrast, the Jan/Oct spread widened slightly by 5 cents, trading at \$0.70 in 30kt to \$0.75 in 50kt. Further down the curve, Q1/Q2 traded at \$1.70 in 15kt, remaining unchanged throughout the day.
