China's state oil majors are racing to keep up with the nation's breakneck energy transition, shifting operations from loss-making gasoline and diesel to alternative fuels and high-end chemicals. Russian crude oil shipments to Hungary may resume on Thursday after almost a week of halt following Ukraine's attack on Druzhba pipeline network. The European Union is mulling introducing secondary sanctions in an effort to prevent third countries from helping Russia circumvent the bloc's existing punitive measures against Moscow, according to people familiar with the matter. Vitol Group is set to load the first cargo of Syrian crude oil since the lifting of western sanctions on Damascus as the country's energy industry attempts to recover from more than a decade of destruction from armed conflict.






