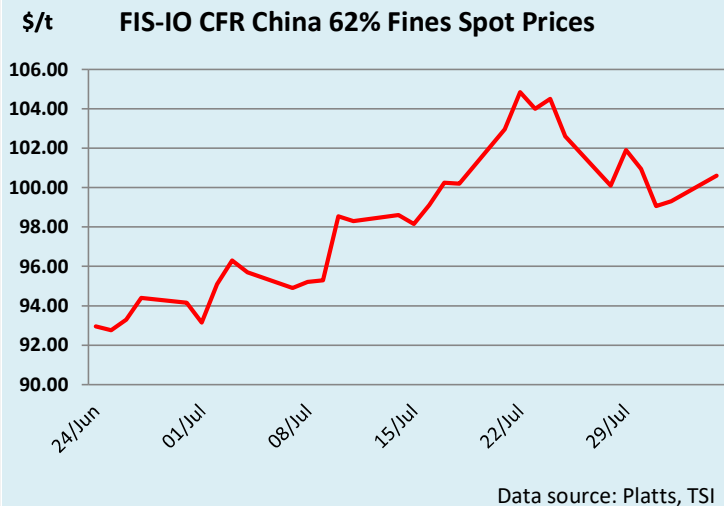

Market Commentary / Recent Trades

The Singapore morning session opened at \$100.45, flat price then dropped to a low of \$100.00 before rising to a high and close of \$101.15. Little activity was seen in this session regarding outright and spreads. Outrights saw the bulk of activity further down the curve, with Q4 trading in two clips of 10kt and Q1 trading in 4kt.

Spreads were seen in prompt months, with Sep/Oct trading at -\$0.05 in 30kt and Sep/Nov at par in 15kt. The most noticeable trade of the session was Sep/Dec trading at \$0.15 in 200kt.

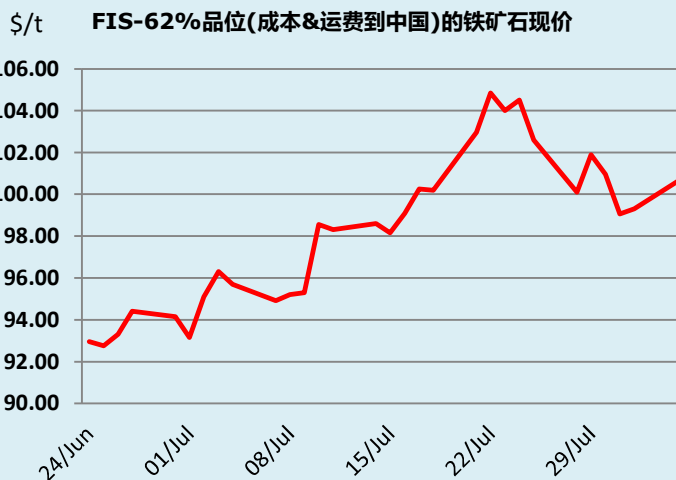

价差方面，即期合约价差是主力合约。9月/10月在负0.05美元交易3万吨，9月/11月价差持平，交易1.5万吨。9月/12月交易量可观，在0.15美元交易20万吨。
