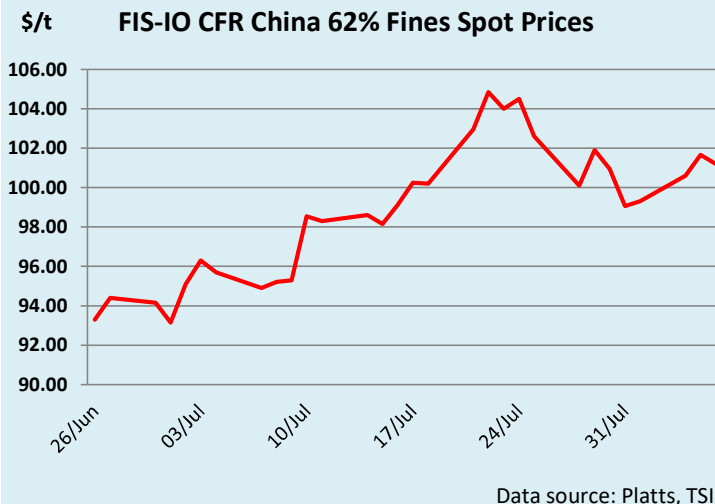

## Market Commentary / Recent Trades

The Singapore morning session opened at \$101.75. The flat price then fell to a low of \$101.30 before rising to a high of \$102.30 and closing at \$102.20. Activity during the session was limited, with prompt month outrights trading in small volumes, while Q4 traded in clips of 5kt and 10kt.

Not much spreads trading were observed during the session with spreads widening slightly compared to the previous day.

TS billet was up ¥10 at ¥3090 this morning. As expected, DCE Iron Ore Sep25 pulled back slightly without a sustained rebound. Short-term price volatility has decreased significantly. Iron ore prices rose yesterday, driven by strength in the coking coal market.

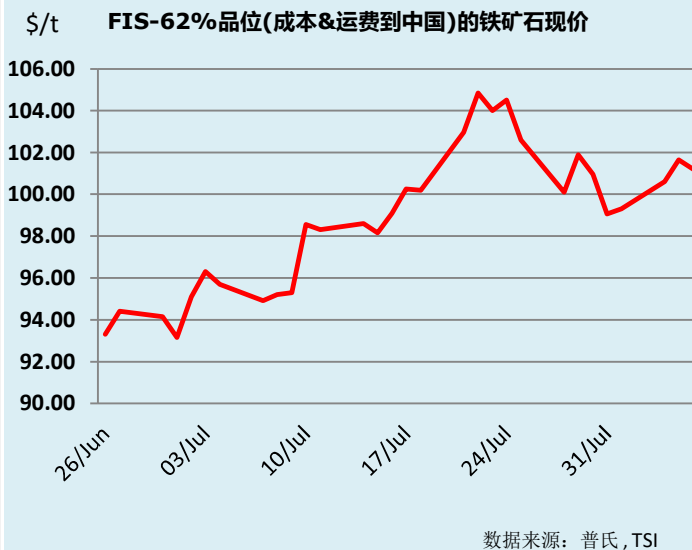

今早新加坡开盘于101.75美元，8月价格下跌至101.30美元的低点，随后反弹至102.30美元的高点，最终收于102.20美元。整体交易清淡，即期合约有少量交易，Q4交易5000吨和1万吨。

盘中缺乏价差交易，价差相较前一交易日略有扩大。

唐山钢坯今早上涨10元至3090元/吨。大商所铁矿石9月合约小幅回落，尚未出现反弹，短期价格波动明显降低。昨日由于焦煤市场走强推动铁矿石价格上涨。
