FUTURES MARKET COMMENTARY

Urea futures saw moderate activity today, with August NOLA Urea futures trading twice at \$460 in 0.5kt, twice in 3kt and 1.5kt at the same price. Oct NOLA Urea futures traded at \$442 in 1.5kt.

The market remains cautious ahead of India's tender results, which are expected to guide near-term sentiment.

Tariff concerns in the U.S. and ongoing drone strikes in Russia are adding to the geopolitical risk premium, while Egypt is reportedly operating at around 80% capacity due to extreme heat, with renewed gas curtailment risks looming.

Traders are staying on the sidelines, awaiting clearer direction.
