Urea markets remained quiet as participants await clarity on the outcome of the Indian tender. Market consensus leans toward confirmation of the 2.6 million tonnes, but no official announcement has been made.

Later in the week, a meeting between Putin and Trump is scheduled, with potential discussions on tariffs affecting Russian fertilizer.
