Lithium Hydroxide Commentary

Following news of CATL's Jianxiawo lithium mine resumption plan, CME lithium hydroxide trading surged, especially in Q1 '26 (558 tons). GFEX lithium carbonate front-month contract slumped -2.54% into the close, while the SMM lithium carbonate index rose +94. The spot premium over the front-month widened again to around 1,700. CME lithium hydroxide average transaction prices dropped sharply across the curve: Q4 '25 –0.37, Q1 '26 –0.59, and Q4 '26 – 1.0 DoD.
