The London afternoon session opened at \$105.55, flat price then fell to a low of \$105.35 before climbing to a high of \$105.95 and closed at \$105.55. Little activity was seen in this session with activity coming in outrights further down the curve, Q3-27 traded in multiple clips totalling 85kt. Spreads tightened in prompt months, Sep/Oct moved back into contango from par in the previous session trading at -0.15 in 45kt whilst further down the curve Q4/Q1 continued to trade at \$3.65 in three clips of 10kt.
