
The London afternoon session opened at \$105.90, flat price then fell to a low of \$105.70 before climbing to a high of \$106.45 and close of \$106.20. Little activity was seen in this session with prompt months trading in smalls. As expected, Oct/Nov saw liquidity trading in multiple clips at par totalling 107.5kt, whilst Sep/Oct continued to stay in contango trading at \$-0.45 in 35.7kt.


