Ukraine attacked the Saratov crude-oil refinery in Russia's Volga region overnight as Western nations seek to push President Vladimir Putin to the negotiating table. OPEC+ delegates will hold initial discussions about their production capacities at a meeting this week, a step that may ultimately influence how much the alliance allows member nations to pump in future. The number of cargo-carrying vessels engaged in international trade passing through the Suez Canal was at 282 last week, the highest level this year, according to the Joint Maritime Information Center. The US government is considering two proposals that will likely help farmers by requiring larger oil processors to make up for lost biofuel demand. China issued its third batch of fuel-export quotas for 2025, allocating 8.395 million tons for clean products.




