California's energy regulator is on the lookout for oil traders trying to game the state's gasoline market as fuel supplies tighten. Russia's weekly crude exports slumped, driven by a slide in Baltic shipments, following Ukrainian drone strikes that hit regional facilities. The US exported the most crude in almost two years, as easing trade tensions with the Trump administration prompted more purchases. For every barrel of crude, America's biggest oil field produces about three to five barrels of wastewater. It's increasingly becoming a problem. Total US crude inventories plunged by more than 9 million barrels to about 415 million barrels, the lowest since late June. Reality in the West Bank reveals that for 3 million Palestinians diplomacy can't disguise that the viability of such a state is crumbling.






