President Donald Trump said Russian President Vladimir Putin had "really let me down," but insisted allies must stop purchasing oil from Moscow if they want the US to pressure the Kremlin to end the war in Ukraine. Exxon Mobil Corp. will pursue fossil-fuel growth long into the future to meet demand it says will "not materially change" between now and 2050. Two Russian refineries were attacked on Thursday as Ukraine stepped up strikes on its enemy's energy infrastructure. Abu Dhabi's energy investment firm XRG's biggest effort yet fell apart this week, while another deal hangs in the balance. A flurry of oil options trades over recent weeks bore the hallmarks of the hedging program of Malaysian's Petroliam Nasional Bhd.




